Once you complete all of your data entry, you can: export the tables as a PDF, save each separate table as an image, or have your web designers recreate them in the format that they require. It is critical that you keep the row and column labels exactly as they appear in these tables. Your program will be considered out of compliance with the IR if they are not consistent with this document.
